LIFETIME COMMERCIAL LIMITED WARRANTY STATICSTOP OHMSTYLE II CARPET TILE

The following warranties apply to Ohmstyle II Carpet TIle Products (Products) when installed and maintained according to installation and maintenance instructions provided by SelecTech, Inc. ("SelecTech") or its Static Control Division, StaticStop. The warranty period for any Products shall commence on the date of purchase of such product from SelecTech or a SelecTech-authorized reseller.

LIFETIME COMMERCIAL LIMITED WARRANTY for Ohmstyle II™ ESD CARPET TILE Lifetime warranty on electrical properties on all Ohmstyle II ESD floor covering products from SelecTech, Inc..

Ohmstyle II Carpet Tiles feature EcoWorx™ backing, a high performance pre-coat laminated to a proprietary state-of-the-art thermoplastic polyolefin compound with a fiberglass reinforcing layer.

The following is the Lifetime Commercial Limited Warranty issued by SelecTech, Inc., Inc for our Ohmstyle II ESD Carpet tile with EcoWorx backing.

This Lifetime Commercial Limited Warranty begins when the carpeting is purchased. The carpet must be installed in accordance with SelecTech, Inc. installation guidelines and specifications. The carpet must be maintained in accordance with SelecTech, Inc. maintenance (carpet care) recommendations and such maintenance (carpet care) continues throughout the duration of the original installation.

The Lifetime is further limited to the period of time the carpet is owned and maintained by the original end-use purchaser. The basis of any warranty related claim is the original SelecTech, Inc. invoice or authorized Julie dealer invoice.

This Limited Warranty covers the following elements and is subject to the following limitations:

FIBER: ABRASIVE WEAR

SelecTech, Inc., Inc. warrants that its product will lose no more than 10% pile face fiber, by weight during the lifetime warranty period. This warranty does not cover appearance retention, matting and crushing or normal appearance changes in high traffic areas.

FIBER: STAIN WARRANTY

SelecTech, Inc., Inc. warrants, for the duration of this warranty that carpet made exclusively with 100% Solution dyed nylon, will resist permanent stains caused by spills of all acid base substances.

FIBER: COLORFASTNESS to Light and Atmospheric Contaminants Warranty

SelecTech, Inc., Inc. warrants that carpet made with 100% Solution dyed nylon, when installed and maintained as recom-mended by SelecTech, Inc., for indoor use only, will not display a significant change in color due to exposure to light or exposure to atmospheric contaminants (Ozone or Oxides of Nitrogen) for the warranty period.

FIBER: STATIC PROTECTION

SelecTech, Inc., Inc. warrants during the period that its Ohmstyle II ESD product will prevent electrostatic buildup in excess of 2.0 kV when tested using AATCC Test Method 134 at 20% RH and will meet the electrical resistance of 25,000 Ohms minimum, 108 ohms maximum (MC ESD) or 109 Ohm maximum (CompuTile LAN) when tested according to NFPA99 and ESD S7.1 test methodology.

BACKING: TUFT BIND

SelecTech, Inc., Inc. warrants that the high performance thermoplastic polyolefin tile backing system will provide superior tuft bind properties in high traffic environments for the lifetime warranty period.

BACKING: EDGE RAVEL

SelecTech, Inc., Inc. warrants that the high performance thermoplastic polyolefin tile backing system will not edge ravel, for the lifetime warranty period.

BACKING: INTEGRITY/DELAMINATION

SelecTech, Inc., Inc. warrants that the secondary backing of this product will not delaminate from the primary backing during the warranty period. This also warrants, under normal use, against "cupping," "doming," "curling," or "dishing" of carpet tiles.

NOTIFICATION OF CLAIMS AGAINST WARRANTY

This warranty does not cover dissatisfaction, problems or damage due to installation or maintenance other than as recommended by SelecTech, Inc.. All claims under this warranty must be submitted, in writing, within five (5) days of discovery of any defect to:

Status of claims will be based on complete inspection of installation. All claims not submitted in writing and received by SelecTech, Inc. within the time period specified above shall be waived.

OBLIGATIONS OF WARRANTOR

SelecTech, Inc., Inc. will, within thirty business days of receipt of a written claim under this limited warranty, designate a representative to inspect the product and evaluate the warranty claim. Any portion of the Ohmstyle II ESD carpet not performing as stated will be repaired to conform to the warranty. If repair is not commercially practical, SelecTech, Inc., Inc. may, at its option, replace the affected carpet or refund the proportional purchase price for the affected area. Carpet installed on stairs or in areas subject to pallet jacks, forklifts, or abnormal foot traffic is excluded. This warranty does not cover burns, cuts, fading, matting, pills, odor, soiling, staining, tears or damage due to improper installation or due to improper cleaning agents or methods. Incidental and consequential damages are not the responsibility of SelecTech, Inc., Inc., and, to the extent permitted by law, are hereby excluded as to both property damage and personal liability. Replacement carpet will come only from current running-line standard performance products comparable to the warranted product.

YOUR SOLE AND EXCLUSIVE REMEDY FOR ANY DEFECT IN ANY PRODUCT SHALL BE THAT SET FORTH ABOVE IN THIS LIMITED WARRANTY. IN NO EVENT SHALL SELECTECH, INC., INC. BE LIABLE TO THE CUSTOMER, ITS EMPLOYEES OR AGENTS OR TO ANY OTHER THIRD PARTY FOR ANY INDIRECT, SPECIAL, EXEMPLARY, INCIDENTAL OR CONSEQUENTIAL
